In addition to paying the purchase price for the acquisition of the shares, the obligation to maintain the company's shipbuilding activities throughout the entire maritime domain covered by the concession is required.

Only bidders who purchase the bidding documentation during the public collection of bids have the right to submit a bid. The procedure for submitting bids and selecting the most favorable bidder is carried out in accordance with the conditions prescribed in the bidding documentation.

The cost of obtaining the bidding documentation is 2.000,00 EUR with the note that the bidding documentation is being purchased for the company 3. MAJ Rijeka 1905 d.o.o. for shipbuilding, Rijeka and the exact name of the bidder.

A bid that is not submitted and prepared in accordance with the terms of the bidding documentation will be rejected. The payment slip used to purchase the bidding documentation must indicate the exact name of the bidder, otherwise the bid will be considered invalid and will not be considered. Upon presentation of proof of payment for the bidding documentation and submission of contact information, the bidder will be provided with a Confidentiality Statement form. After signing the aforementioned Statement, the bidder acquires the right to receive the bidding documentation and request authorization from CERP to conduct a due diligence review of the Company.

Bid guarantee in the amount of 66.650,00 EUR must be enclosed with the binding bid. Bid guarantee can be in the form of a bid bank guarantee from, issued from a domestic or foreign bank, or the specified amount is paid as a guarantee to the CERP account.
